Business Manager Report – The City is considering our request to assist with expenses for boiler installation and the feed tank installation. The total for both installations is about \$15,000. The City has recommended the Board request money from the City as well. The AARP tax assistance program has been very busy this year. We are working with Leavitt Insurance to get new insurance as MACo will discontinue insurance coverage for non-profits this year. The Rainbow Enterprises floor has been completely installed. The Pioneer Club is selling banquet tickets at Center for the upcoming banquet. The foot clinic has been funded through a grant for the next year.

Treasurer Report – Jan is not available for report.

Committees

- Fundraising We will continue to develop strategy for having sponsorships for programs. Leah and Lisa will meet to work on development.
- Resident committee Report Dean reported that the cleaning has recently been subpar, the floors have not been vacuumed recently. Hannah reported that a new cleaning person will be starting next week. Dean also said some apartments are still waiting for installation of high toilets. We are looking into current status of which have been completed and which still need to be completed.
- Programs committee The garden spot at the Lincoln School through the Farm to School program will be ready for planting in early May. We will have a meeting this Friday with all interested gardeners to make a plan. Bob Dyer set up another jam session. The next jam session will be Saturday April 22 in the afternoon. Cynthia is interested in forming a
